SPILL CLEAN-UP PROCEDURES:

Keep all sources of ignition and hot metal surfaces away from spill. Avoid contact with eyes or skin. Place leaking containers in well ventilated area. If fire potential exists, blanket spill with foam or use water spray to disperse vapors. Contain spill to minimize contaminated area and facilitate salvage or disposal.
